



End User License Agreement (EULA) of Christine Gertsch, All about Type, Kochstrasse 18, 8004 Zürich (hereinafter "Christine Gertsch")

Modono Standard License

By downloading and /or installing this font package, you are agreeing to be bound by the terms of this Agreement. This Agreement constitutes the complete agreement between you (the licensee) and Christine Gertsch.

We grant the Licensee a non-exclusive license, unlimited in time and place, to use the Font Software for private or business purposes.

1. You are purchasing the license to use digital typeface software (hereafter "fonts"). You are not purchasing the copyright to the design of the fonts, but the right to use the fonts.
2. With 1 licence, you may use the fonts on a maximum of 3 computers within your company. It is possible to purchase additional licenses at any time. You are also purchasing an unlimited amount of licenses to use "Modono" fonts on web servers under your control, and under the control of your single company/organization. You are purchasing so-called self-hosted fonts that you host on your own servers.
3. You may use the licensed fonts to create EPS files or other scalable drawings provided that such files are only used by the household or company licensing the font.
4. You may make archival copies of the fonts for internal purposes. You are not allowed to distribute the fonts to people that do not belong to your company. You may provide the font to a printer, designer or prepress bureau if necessary. In that case, they have to agree to the terms of this license and may not retain any copy of the font after completion of the work.
5. You may embed the licensed fonts into any document you send to third parties. Such documents may be viewed and printed (but not edited) by the recipients. You may not under any circumstances embed the licensed fonts into software or hardware products in which the fonts will be used by the purchasers of such products. Such use requires a different license which may be offered by Christine Gertsch. Please contact cg@christinegertsch.net for further information.
6. You may import characters from the font as graphical objects into a drawing program and modify such graphical objects for your own purpose, but the copyright remains with Christine Gertsch. You may not modify, adapt, translate, reverse engineer, decompile, disassemble, or create derivative works based on the licensed font itself without Christine Gertsch's prior written consent.
7. The font, the InDesign Plugin and the accompanying materials are copyrighted and contain proprietary information and trade secrets belonging to Christine Gertsch owning the font. Unauthorized copying of the Product even if modified, merged, or included with other software, or of the written materials, is expressly forbidden. You may be held legally responsible for any infringement of the Christine Gertsch's intellectual property rights that is caused or encouraged by your failure to abide by the terms of this Agreement.
8. You are not allowed to use otf-fonts with any web font replacement technologies which provide third-party access to the font files, such as @font-face. The use of the Font Software takes place exclusively through the integration of the Font Software into a Website as web fonts in WOFF2 format via the CSS-@font-face rule. The Licensee is responsible for ensuring that the web fonts cannot be used or referenced by other Websites. Appropriate technical protection measures are to be taken for this – as far as necessary.
9. If the actual use of the Font Software by the Licensee exceeds the scope agreed in the Usage Agreement, the Licensee is obliged to purchase a license extension from Christine Gertsch that covers the actual scope.
